Entry to the Albury Wodonga Yacht Club (AWYC) grounds and involvement in the 2016 Sail Country Regatta is conditional on providing the details as above and agreeing to the conditions outlined below.

Terms and Conditions of Entry

1. The craft shall only be moored in the location as directed by an AWYC representative. Specifically, vessels are not to be moored at the pontoons at any time.
2. Fuel is not available at AWYC. Closest fuel is available at the Kangaroo Point Store, Bonegilla Road.
3. Registered Coach/Support boats will be required to fly a supplied flag to make them identifiable on the course. A deposit of \$20 is to be paid for the flag and will be refunded upon its return. (Flags will have a tie and boats are to supply their own way of mounting to their vessel).
4. All skippers of Coach/Support boats must attend a briefing with Race Management. This is scheduled for after the Competitor's Information Session in the AWYC Clubhouse. (Approx 11:20am on Saturday 29/10).
5. Coach/Support boats may not enter the race area, unless directed to do so by the Race Management Team.
6. Coach/Support boats will be required to assist in the event of an emergency if directed to do so by the Race Management Team.
7. Each Coach/Support boats will be issued with a Safety Guide which has a map of course areas, radio channels and emergency procedures. They will also be issued with red/white tape to be placed on an abandoned boat in an emergency situation (further details at briefing).
8. All boats must have a VHF radio capable of working on all usual Australian channels, and maintain a listening watch on the channels specified by the Race Management Team. ie. 16, 71, 72, 73, 74, 77
9. All drivers of a Coach/Support boats must hold a current powerboat licence.
10. Coach/Support boats must have a current boat insurance policy with a minimum value of \$5,000,000 or more for public liability insurance.
11. Lifejackets (PFDs) are to be worn at all times by the skipper and passengers on Coach/Support boats (as will crews on Race Management vessels).
12. I agree to comply with any reasonable request from the Race Management Team or AWYC representative.
